Therefore, I at this moment release, waive, discharge, and relinquish any claims or rights to claims and assume all risks of bodily injuries to the minor, including medical or hospital bills, partial or permanent disability, damages for death, personal injury, or property damage which I may have, or which may hereafter accrue to me, as a result of said minor's participation in said activity. This release is intended to discharge in advance the promoters, sponsors, The Mack Calvin Youth Empowerment Foundation ("Permittee/Sponsor"), its officers, the officials, and any involved municipalities or other public entities (and their respective agents and employees) from any liability, loss, damage, claim, demand or cause of action against them arising from or attributable to my participation in the event or activity whether same shall occur by their negligence, carelessness, or otherwise on the part of the persons or entities mentioned above.

"In the event of sudden illness, accident or injury which may occur while said minor in an activity supervised by The Mack Calvin Educational & Fundamental Basketball Camp and their representative, agents, or assignees, when neither the parent(s), guardian(s) can be contacted, I at this moment give my consent to secure emergency medical treatment at the parent(s) or guardian(s) expense.
